NKN DNS Policy

This Policy outlines the principles and configuration of Domain Name Services on NKN authorized servers.

About DNS Server

DNS is an Internet service used to resolve system names to network addresses and vice versa. MX DNS queries identify the mail servers configured to accept incoming e-mail for a given domain.

NKN DNS SERVERS

NKN provides variety of DNS services for its users. NKN is managing numbers of authoritative DNS servers which are placed at geographically different locations in the country to maintain redundancy, high availability and minimize latency. NKN can also provide DNSSEC services to its users.

1. DNS entry under NKN.IN

Domain NKN.IN is allotted to National Knowledge Network (NKN). 3rd and 4th level domains of NKN.IN are being used by various websites hosted in National Knowledge Network. Domain name NKN.IN is restricted to user Institutions/ organizations of NKN.

2. DNS entry for other Domains

NKN is providing DNS services free of cost to the institutions and organizations which are connected with NKN. NKN provides DNS services for various domains like, .in, org.in, res.in, ac.in etc. Domains should be registered with designated registrar for this purpose.

3. Reverse DNS Requirements (PTR Entry)

User must meet the following conditions, to initiate the process of making reverse DNS (PTR) entry:-

- 3.1 User had obtained IP address space/block from NKN
- 3.2 User has to decide which IP address requires PTR entry

4. Procedure for DNS entry

To maintain proper records and to avoid unwanted DNS entry, applicants must adhere to the following steps-

4.1 A standard DNS-request form is prepared and applicant will have to fill all the fields of the form. DNS-Request form is available at <https://www.nkn.in>

4.2 Duly signed & stamped DNS-Request form should be sent to support.dns@nkn.in.

4.3 Upon completion of DNS entry, DNS team will inform to the concerned applicant through E-mail.

4.4 All types of DNS requests like modification, deletion, MX, PTR etc will be accepted through DNS-Request form only.

4.5 For creation of sub-domain entries, user will have to send request using attached DNS request form.

4.6 Domain names may be registered for a minimum period of one (1) year, and a maximum period of ten (10) years.

4.7 NKN will follow the prevailing IT Act and Cyber law of Government of India from time-to-time.

5. DNS Service Support Modalities:-

5.1 Domain name and IP Address provided by Director/Head of the Institute will map in NKN DNS servers listed in table-1.

5.2 Director/Head of the Institute may nominate maximum two Nodal Officer(s) from their Department/Institute for day-to-day DNS related works. NKN DNS team will accept DNS addition/modification requests from nodal officer after authorization by Director/Head of the Institute in the attached format

5.3 Director/Head of the Institute will have to inform NKN DNS team if any new nodal officer added or removed, so that DNS team will accept DNS request accordingly. At any point of time total number nodal officers per zone/ domain cannot exceed two.

5.4 NKN does not provide Domain Name registration services. The Customer is responsible for registering their own domain with an appropriate registrar.

5.5 NKN will remove zones from its primary and secondary DNS servers, if it is found that the domain/ zone is no longer pointed to NKN Authoritative name servers.

5.6 Project Director (NKN) will be the only authority to approve any exceptions.

6. Purpose

Purpose of this document is to provide the information and procedures for DNS entry in NKN Authoritative DNS Servers.
