

# User Agreement for NKN Mail Gateway Service





# WELCOME TO NKN

Thanks for using our Product & Services. The service is provided by National Informatics Centre (NIC),located at Block- A, CGO Complex, Lodhi Road, New Delhi, India.

By using this service, you are agreeing to the terms and conditions mentioned below. Please read them carefully.

# **TERMS OF SERVICE**

This legal agreement between you and National Informatics Centre (NIC), governs your use of the NKN Mail Gateway service.

NIC is the provider of NKN Mail Gateway service, which enables you to send and receive mails to and from internet under the terms and conditions mentioned in this agreement.

The NKN Mail Gateway Service is available to you only in India and its territories. Your Mail server should be hosted in NKN network and using NKN Mail Gateway services you can send mails to internet and any mail sent to your domain from internet can be received.

Use of NKN Mail Gateway Service requires compatible devices, internet access, and certain software .e.g. Mail Transfer Agents (MTA) You agree that it is your responsibility to meet these requirements which may change from time to time. The NKN Mail Gateway Service is not part of any other product or service or offering under NKN project, and obtaining any other product under NKN shall not guarantee you access to the NKN Mail Gateway service.

### **USER ACCOUNT**

To access the NKN Mail Gateway service on NKN, you must have all the userids created in the NKN LDAP. Any mail which is destined for the existing user in NKN LDAP can be accepted at NKN Mail Gateway. You are solely responsible for maintaining the confidentiality and security of your accounts. All activities that occur on or through your accounts are your responsibility, and you agree to immediately notify NIC of any security breach of your accounts. NIC shall not be responsible for any losses arising out of the unauthorized use of your accounts.

You agree to provide accurate and complete information when you register and use NKN Mail Gateway service.

# **PAYMENT**

The NKN Mail Gateway service provided to you under NKN project is free of cost. However, you understand that in future NKN may decide to charge a fee for this service.



# **PRIVACY**

When you opt for NKN Mail Gateway service, NIC will time to time automatically collect information shared by you during registration and update purposes that can be used for ensuring smooth communication between NIC and user institute.

### **CONTENT AVAILABLITY**

NIC reserves the right to change service, its content and eligibility for particular service without giving any prior notice to the user.

# **USE OF SERVICES**

You shall use NIC Products in compliance with the applicable usage rules established by NIC NKN and that any other use of the NIC Products may be considered as a copyright infringement. NIC reserves the right to change the Usage Rules at any time. Usage Rules may be controlled and monitored by NIC for compliance purposes, and NIC reserves the right to enforce the Usage Rules without notice to you. You shall not access or attempt to access an Account that you are not authorized to access.
